PAYMENT:

_____ I understand that lessons are formed based on the commitment of student and their parents. As such, first month's tuition, due with this signed agreement are **NON-REFUNDABLE** once I am assigned to a specific, mutually agreeable class time. (In the unlikely event that a mutually agreeable class time cannot be arranged, I will be refunded 100%).

_____ I understand that tuition is due in advance each month by the first day of the month. If paid after the 1st, a late fee of \$10.00 will be added to my account. If paid after the 14th, an additional late fee of \$10 will be added to my account.

_____ I understand that I must give a 30-day notice of discontinuation of lessons. I understand even if I cannot attend lessons a full month, no refund will be given.

AT-HOME TIME COMMITMENT: Results are achieved easily and naturally if all of the teacher's instructions are followed. This will include a regular, consistent practice time at home, utilizing the student home materials as instructed, and actively participating in class. Your Simply Music School Teacher is trained and licensed to teach the SM curriculum. She/he is your coach who, once per week, teaches you tools and strategies that you process and master at home in between lessons. She/he is your **METHOD COACH**. It is the parent, or **LIFE COACH**, who must consistently guide and support the student at home. This is a small investment of time which can have a lifelong impact. Adult students serve as their own **LIFE COACHes** at home.
